

## NOTES ON CONTRIBUTORS

**Jonathan Blakeley** is Director of Administration at the University of Auckland. While the General Manager of the Auckland Institute of Technology, he completed a Master of Public Policy degree at Victoria University of Wellington. As part of this degree he wrote a thesis on the 'Accountability and Autonomy of New Zealand Universities'.

**Jonathan Boston** is Professor of Public Policy at Victoria University of Wellington. He has published books and articles on a range of public policy issues including, incomes policy, the funding of tertiary education, aspects of social policy, and public management. He is currently a member of the 'New Zealand Political Change Project', which is examining the impact of proportional representation on New Zealand's political system and is funded by the Foundation for Research, Science and Technology. Recent books include: *Governing Under Proportional Representation, Redesigning the Welfare State* in New Zealand (co-edited), and *From Campaign to Coalition* (co-edited).

**Ruth Butterworth** is now retired from her position at the University of Auckland where she was Associate Professor of Political Studies. She is the joint author, with Nicholas Tarling, of *A Shakeup Anyway: Government and the universities in a decade of reform* (1994). She has had a long-standing interest in the politics of education and held the post of Academic Vice-President of the Association of University Staff.

**Richard A. Epstein** is the James Parker Hall Distinguished Service Professor of Law at the University of Chicago, where he has taught since 1972. Previously, he taught law at the University of Southern California from 1968 to 1972. He has been a member of the American Academy of Arts and Sciences since 1985 and a Senior Fellow of the Center for Clinical Medical Ethics at the University of Chicago Medical School. He served as editor of the *Journal of Legal Studies* from 1981 to 1991, and since 1991 has been an editor of the *Journal of Law and Economics*. His books include *Principles for a Free Society* (Perseus Books, 1998), *Mortal Peril: Our inalienable right to health care?* (Addison-Wesley, 1997), *Simple Rules for a Complex World* (Harvard University Press, 1995), *Bargaining With the State* (Princeton, 1993), *Forbidden Grounds: The case against employment discrimination laws* (Harvard, 1992), *Cases and Materials on Torts* (Little, Brown, 5th ed. 1990), *Takings: Private Property and the Power of Eminent Domain* (Harvard, 1985), and *Modern Products Liability Law* (Greenwood Press, 1980). Professor Epstein has written numerous articles on a wide range of legal and interdisciplinary subjects and taught courses in contracts, criminal law, health law and policy, legal history, property, real estate development and finance, jurisprudence and taxation, torts, and workers' compensation.

**Jane Kelsey** has degrees from Victoria University of Wellington, Oxford and Cambridge universities and a PhD from the University of Auckland. She holds a personal chair in law at the School of Law, Auckland University and specialises in the area of law and policy, both domestic and international. Professor Kelsey is the author of four books on aspects of the restructuring of New Zealand's economic, political and social life since 1984, including *The New Zealand Experiment: A world model for structural adjustment?* (Auckland University Press/Bridget Williams Books, 2nd edn, 1997). Her latest book, *Reclaiming the Future: New Zealand and the global economy*, challenges prevailing views about globalisation and its implications for the future. Professor Kelsey travels extensively, talking on the New Zealand experience to a wide range of audiences, and is an active member of an international

network of scholars who are critical of the global free market economy. Jane has served as a sub-professorial representative on the Council, the Senate and numerous university committees. She is now an active professorial representative on the Senate and a member of the Vice-Chancellors advisory committee on the tertiary education review. In 1998 Jane was the Academic Vice-President of the Association of University Staff, with particular responsibility for the tertiary review, and was the National President in 1999.

**Roger Kerr** is the Executive Director of the New Zealand Business Roundtable, an organisation of chief executives of around sixty of New Zealand's larger business firms. The Business Roundtable is interested in major public policy issues, including legislation affecting the business sector. Mr Kerr has previously worked in the Ministry of Foreign Affairs and the Treasury. He was a director of the Electricity Corporation of New Zealand and is currently on the Australasian board of Colonial limited. Mr Kerr also is a member of council at Victoria University of Wellington.

**Simon Marginson** is a Reader in Education at Monash University in Australia, and Director of the Monash Centre for Research in International Education. Working in higher education, international and comparative education, and education policy and management, he is the author of five books including *Education and public policy in Australia* (Cambridge UP, 1993), *Educating Australia: Government, economy and citizen* (Cambridge UP, 1997), and *Markets in education* (Allen and Unwin, 1997). In 2000 his *Monash: The remaking of the university* will be published by Allen and Unwin; and with Mark Considine he recently completed a study of governance and management in Australian universities, titled *The enterprise university*. He chairs the Editorial Board of Australian Universities Review and his articles have been published in journals as diverse as *The Cambridge Journal of Economics*, *Labour Economics and Productivity*, *Higher Education*, *Studies in Higher Education*, *Comparative Education Review*, *Leading and Managing* and *Thesis Eleven*. His current research projects include an Australian Research Council-financed study of the internationalisation of Australian universities (with Fazal Rizvi), and a cross-country study of leadership perspectives and strategies in universities in four countries. In 1997 he was awarded the University of Melbourne doctoral award and the Australian Association for Research in Education doctoral award, for his thesis entitled 'Markets in education'.

**Hirini Mead** was Professor of Maori Studies at Victoria University of Wellington. He is the author of numerous books and articles. Dr Mead is one of the founders of Awanuiarangi.

**Michael Peters** is Associate Professor in the School of Education, University of Auckland, New Zealand. His research interests are in educational philosophy, theory and policy. He has published a number of books, including: *Poststructuralism, Politics and Education* (Westport, Conn. & London, Bergin and Garvey, 1996); *Individualism and Community: Education and social policy in the postmodern condition* (London, Falmer Press, 1996) with James Marshall; and with Henry Giroux, Colin Lankshear and Peter McLaren, *Counternarratives* (London, Routledge, 1996). He has also edited a number of collections, including: *Education and the Postmodern Condition* (1995), *Naming the Multiple: Poststructuralism and education* (1998), both with Bergin and Garvey; *Critical Theory, Poststructuralism and the Social Context* (1996) with Wayne Hope, James Marshall and Stephen Webster; *Cultural Politics and the University* (1997) and *Virtual Technologies in Tertiary Education* (1998) with Peter Roberts, all with Dunmore Press (NZ).
